

# Indoor & Outdoor Visitation is Possible

Applicable to: facilities without an outbreak or facilities with outbreak after 1st round of testing

The Illinois Department of Public Health (“IDPH”) and Centers for Medicare & Medicaid Services (“CMS”) have recently released guidance for Skilled Nursing Facilities and Other Long-Term Care Facilities to follow, regarding COVID-19 and re-introducing group activities and visitation.

Per IDPH’s Reopening Plan for Skilled Nursing Facilities and Other Long-Term Care Facilities Avantara Lake Zurich **is currently allowing in person visitations.** Although outdoor visitation is strongly encouraged by IDPH and CMS, both indoor and outdoor visitations may be available, subject to Avantara Lake Zurich’s availability and IDPH’s and CMS’ guidelines and regulations, which may change from time to time. Additionally, group dining and group activities at our facility have been expanded and salon services may be offered. Please note, visitation availability, group dining and activities, and salon services are subject to change based on a variety of factors, including possible new guidance and recommendations. # Indoor Visitation Policy



## Dear Family and Friends,

**We are excited to welcome you back to Avantara Lake Zurich. Please see the below details on our indoor visitation policy.**

- Visiting hours at the Facility are between Monday - Friday 10:00 a.m. - 6:30 p.m. and on the weekend 10:00 a.m. - 4:00 p.m.
- Outdoor visits are strongly encouraged, weather permitting, and are strongly preferred over indoor visits.
- When a visitor arrives, reception will screen the visitor to the same extent it screens all other persons that enter the facility. The screening will include questions as to whether the visitor experiences any symptoms of COVID-19 or has had close contact with anyone with COVID-19.
  - If a visitor does not pass the screening, the visit cannot be conducted.
- Visitors will be required to wear proper PPE, (mask may be provided by the facility but N95 respirator won't) subject to certain exceptions and will be required to comply with the facility's policies and procedures in regard to masking, social distancing, hand hygiene, infection control, and other COVID-19 related policies and procedures.
- If the visit is to take place in a designated visiting area, the resident will be escorted by facility staff to the designated visitation area and will be escorted back to their room or other location, after the visit.
- Visitors may not walk around the facility; they may only go to and from the designated visiting area or resident's room, to ensure the safety of the facility's residents and staff.
- Visitors must maintain a 6-foot distance during the visit, from both residents and staff, subject to certain exceptions.
  - Residents on isolation for COVID 19 - Indoor and outdoor visits are generally not allowed except for compassionate care, end-of-life visits, and visits from ombudsman/guardians.
  - Residents on quarantine for COVID 19 (PUIs or suspected to have COVID 19) - Indoor and outdoor visits are generally not allowed except for compassionate care, end-of-life visits, and visits from ombudsman/guardians.
  - Residents on quarantine due to being unvaccinated with a close contact exposure to a positive case – indoor visitation allowed in the resident's room ONLY, and both resident and visitor/s should wear mask and maintain at least 6 feet distancing. No outdoor visit is allowed.
  - Residents on quarantine due to being unvaccinated new admissions or unvaccinated readmissions and due to being unvaccinated & being out of the facility for more than 24 hours – indoor visitation allowed in the resident's room ONLY and both resident and visitor/s should wear mask and maintain at least 6 feet distancing. No outdoor visitation allowed.
  - If both the resident and visitor(s) have been fully vaccinated, there may be close contact, however, both resident and visitor(s) wear a mask. Additionally, hand hygiene must be performed before and after contact.

If both resident and visitor/s are fully vaccinated and the visit occurred in the resident's own room, only the resident may remove his/her mask per IDPH.

However, even if the resident and the visitor/s are both fully vaccinated and the visit occurs in his/her own room, if the resident had a close contact exposure to a positive case, both resident and visitor/s should wear their masks and maintain 6- feet distancing at all times.
- If a visitor fails to comply with the facility's visitation policy, or any policies or procedures of the facility, then the facility staff may end the visit.

# Outdoor Visitation Policy



## Dear Family and Friends,

We are excited to welcome you back to Avantara Lake Zurich. Please see the below details on our outdoor visitation policy.

- Visiting hours at the Facility are between Monday - Friday 10:00 a.m. - 4:00 p.m.
- Outdoor visits are strongly encouraged, weather permitting, and are strongly preferred over indoor visits.
- When a visitor arrives, reception will screen the visitor to the same extent it screens all other persons that enter the facility. The screening will include questions as to whether the visitor experiences any symptoms of COVID-19 or has had close contact with anyone with COVID-19.
  - If a visitor does not pass the screening, the visit cannot be conducted.
- Visitors will be required to wear proper PPE, (mask may be provided by the facility but N95 respirator won't) subject to certain exceptions and will be required to comply with the facility's policies and procedures in regard to masking, social distancing, hand hygiene, infection control, and other COVID-19 related policies and procedures.
- If the visit is to take place in a designated visiting area, the resident will be escorted by facility staff to the designated visitation area and will be escorted back to their room or other location, after the visit.
- Visitors may not walk around the facility; they may only go to and from the designated visiting area or resident's room, to ensure the safety of the facility's residents and staff.
- Visitors must maintain a 6-foot distance during the visit, from both residents and staff, subject to certain exceptions.
  - **Residents on isolation for COVID 19** - Indoor and outdoor visits are generally not allowed except for compassionate care, end-of-life visits, and visits from ombudsman/guardians.
  - **Residents on quarantine for COVID 19 (PUIs or suspected to have COVID 19)** - Indoor and outdoor visits are generally not allowed except for compassionate care, end-of-life visits, and visits from ombudsman/guardians.
  - **Residents on quarantine due to being unvaccinated with a close contact exposure to a positive case** – indoor visitation allowed in the resident's room ONLY, and both resident and visitor/s should wear mask and maintain at least 6 feet distancing. No outdoor visit is allowed.
  - **Residents on quarantine due to being unvaccinated new admissions or unvaccinated readmissions and due to being unvaccinated & being out of the facility for more than 24 hours** – indoor visitation allowed in the resident's room ONLY and both resident and visitor/s should wear mask and maintain at least 6 feet distancing. No outdoor visitation allowed.
  - If both the resident and visitor(s) have been fully vaccinated, there may be close contact, however, both resident and visitor(s) wear a mask. Additionally, hand hygiene must be performed before and after contact.
    - If both resident and visitor/s are fully vaccinated and the visit occurred in the resident's own room, only the resident may remove his/her mask per IDPH.
    - However, even if the resident and the visitor/s are both fully vaccinated and the visit occurs in his/her own room, if the resident had a close contact exposure to a positive case, both resident and visitor/s should wear their masks and maintain 6- feet distancing at all times.
- If a visitor fails to comply with the facility's visitation policy, or any policies or procedures of the facility, then the facility staff may end the visit.
